

Wyost SC, Jubbonti SC and Tyenne IV and SC to require prior authorization for most commercial members starting March 21

For dates of service on or after March 21, 2024, we're adding a prior authorization requirement for most Blue Cross Blue Shield of Michigan and Blue Care Network group and individual commercial members for the following drugs covered under the medical benefit:

- Wyost[®] SC (denosumab-bbdz), HCPCS code J3590
- Jubbonti[®] SC (denosumab-bbdz), HCPCS code J3590
- Tyenne[®] IV and SC (tocilizumab-aazg), HCPCS code J3590

How to submit prior authorization requests

Submit prior authorization requests through the NovoLogix[®] online tool. It offers real-time status checks and immediate approvals for certain medications.

To access NovoLogix, log in to our provider portal (availity.com*), click *Payer Spaces* in the menu bar and then click the BCBSM and BCN logo. You'll find links to the NovoLogix tools on the Applications tab.

Some Blue Cross commercial groups aren't subject to these requirements

For Blue Cross commercial groups, these prior authorization requirements apply only to groups that participate in the standard commercial Medical Drug Prior Authorization Program for drugs administered under the medical benefit. To determine whether a group participates in the prior authorization program, see the [Specialty Pharmacy Prior Authorization Master Opt-in/out Group List](#).

Note: Blue Cross and Blue Shield Federal Employee Program[®] members and UAW Retiree Medical Benefits Trust (non-Medicare) members don't participate in the standard prior authorization program.
