Aucatzyl IV to require prior authorization for most members starting Nov. 21

For dates of service on or after Nov. 21, 2024, we're adding a prior authorization requirement for most Blue Cross Blue Shield of Michigan and Blue Care Network members for the following drug covered under the medical benefit:

• Aucatzyl[®] IV (obecabtagene autoleucel), HCPCS code J3590

The requirement applies to the following lines of business:

- Blue Cross commercial
- BCN commercial
- Medicare Plus Blue
- BCN Advantage

Notes:

- For Blue Cross commercial, requirements apply to all fully insured members (group and individual) and to groups that participate in the standard commercial Medical Drug Prior Authorization Program for drugs administered under the medical benefit. To determine whether a group participates in the prior authorization program, see the <u>Specialty Pharmacy Prior Authorization Master Opt-in/out Group list</u>. Note that Blue Cross and Blue Shield Federal Employee Program[®] members and UAW Retiree Medical Benefits Trust (non-Medicare) members don't participate in the standard prior authorization program.
- For Medicare Advantage members, drugs require prior authorization when administered by a health care provider in sites of care such as outpatient facilities or physician offices and are (a) billed electronically through an 837P transaction or on a professional CMS-1500 claim form or (b) billed electronically through an 837I transaction or using the UB04 claim form for a hospital outpatient type of bill 013x.

How to submit prior authorization requests

Submit prior authorization requests through the NovoLogix[®] online tool. It offers realtime status checks and immediate approvals for certain medications.

To access NovoLogix, log in to our provider portal (<u>availity.com</u>*), click *Payer Spaces* in the menu bar and then click the BCBSM and BCN logo. You'll find links to the NovoLogix tools on the Applications tab.
