More information about the Oncology Value Management program through OncoHealth

As we announced previously, OncoHealth will manage prior authorizations for medical benefit oncology and supportive care drugs for most members through the Oncology Value Management program. This applies to dates of service on or after Jan. 1, 2025.

Start submitting prior authorization requests to OncoHealth on Jan. 1

On Jan. 1, 2025, health care providers will be able to submit prior authorization requests in the OncoHealth Provider Portal, OneUM[™], through Availity Essentials[™].

To access the OncoHealth Provider Portal:

- 1. Log in to the Blue Cross and BCN provider portal (availity.com*).
- 2. Click on Payer Spaces in the menu bar and then click on the BCBSM and BCN logo.
- 3. Click on the OncoHealth Provider Portal tile in the Applications tab.

Members who started receiving treatment before Jan. 1, 2025, can continue to receive treatment under their approved authorization until it expires. Authorization isn't required from OncoHealth unless:

- There's a change to the existing treatment plan on or after Jan. 1, 2025.
- Treatment extends past the authorization end date.
