# Alhemo to require prior authorization for most commercial members starting Jan. 16

For dates of service on or after Jan. 16, 2025, we're adding a prior authorization requirement for most Blue Cross Blue Shield of Michigan and Blue Care Network group and individual commercial members for the following drug:

Alhemo<sup>®</sup> (concizumab-mtci), HCPCS code J3590

Submit prior authorization requests for this medical benefit drug through the NovoLogix® online tool.

#### How to access NovoLogix

To access NovoLogix, log in to our provider portal (<u>availity.com</u>\*), click *Payer Spaces* in the menu bar and then click the BCBSM and BCN logo. You'll find links to the NovoLogix tools on the Applications tab.

### Some Blue Cross commercial groups aren't subject to this requirement

For Blue Cross commercial, this prior authorization requirement applies only to groups that participate in the standard commercial Medical Drug Prior Authorization Program for drugs administered under the medical benefit. To determine whether a group participates in the prior authorization program, see the <a href="Specialty Pharmacy Prior Authorization Master Opt-in/out Group List">Specialty Pharmacy Prior Authorization Master Opt-in/out Group List</a>.

Note: Blue Cross and Blue Shield Federal Employee Program® members and UAW Retiree Medical Benefits Trust non-Medicare members don't participate in the standard prior authorization program.
