

## Qfitlia SC and some denosumab products to require prior authorization for most commercial members for dates of service on or after April 11

For dates of service on or after April 11, 2025, we're adding a prior authorization requirement for most Blue Cross Blue Shield of Michigan and Blue Care Network group and individual commercial members for the following drugs:

- Bomynta SC (denosumab-bnht), HCPCS code J3590
- Conexence SC (denosumab-bnht), HCPCS code J3590
- denosumab-bnht, HCPCS code J3590
- Qfitlia™ SC (fitusiran), HCPCS code J3590

Submit prior authorization requests for these medical benefit drugs through the NovoLogix® online tool.

### How to access NovoLogix

### Some Blue Cross commercial groups aren't subject to this requirement

For Blue Cross commercial, this prior authorization requirement applies only to groups that participate in the standard commercial Medical Drug Prior Authorization Program for drugs administered under the medical benefit. To determine whether a group participates in the prior authorization program, see the [Specialty Pharmacy Prior Authorization Master Opt-in/out Group List](#).

Note: Blue Cross and Blue Shield Federal Employee Program® members and UAW Retiree Medical Benefits Trust non-Medicare members don't participate in the standard prior authorization program.
