- Conexxence SC (denosumab-bnht), HCPCS code J3590
- denosumab-bnht, HCPCS code J3590
- Qfitlia[™] SC (fitusiran), HCPCS code J3590

Submit prior authorization requests for these medical benefit drugs through the NovoLogix® online tool.

To determine whether a group participates in the prior authorization program, see the Specialty Pharmacy Prior Authorization Master Opt-in/out Group List.

Note: Blue Cross and Blue Shield Federal Employee Program® members and UAW Retiree Medical Benefits Trust non-Medicare members don't participate in the standard prior authorization program.
