Additional drugs to have requirements for Blue Cross commercial URMBT members starting Oct. 8

For dates of service on or after Oct. 8, 2025, the drugs listed below will have requirements for Blue Cross commercial UAW Retiree Medical Benefits Trust members. Submit requests as follows.

These requirements apply only when these drugs are administered in an outpatient setting.

Submit prior authorization requests through the Carelon provider portal or the Medical and Pharmacy Drug PA Portal when these drugs will be billed as a medical benefit.

Note: The requirements don't apply to the UAW Retiree Health Care Trust (group number 70605) or the UAW International Union (group number 71714).

How to submit authorization requests

To submit requests, log in to our provider portal (<u>availity.com</u>*), click on *Payer Spaces* and then click on the BCBSM and BCN logo. Click the appropriate tile in the Applications tab:

- *Medical/pharm drug benefit prior auth (commercial)* to open the Medical and Pharmacy Drug PA Portal
- Carelon ProviderPortal
