

Gammagard Liquid ERC to have requirements for most commercial members starting July 14

For dates of service on or after July 14, 2025, we're adding a prior authorization and site-ofcare requirement for most Blue Cross Blue Shield of Michigan and Blue Care Network group and individual commercial members for the following drug covered under the medical benefit:

 Gammagard Liquid ERC[®] IV and SC (immune globulin infusion (human)), HCPCS code J1599

How to submit prior authorization requests

Submit prior authorization requests through the Medical and Pharmacy Drug PA Portal. It offers real-time status checks and immediate approvals for certain medications.

To access the Medical and Pharmacy Drug PA Portal, log in to our provider portal (<u>availity.com</u>*), click *Payer Spaces* in the menu bar and then click the BCBSM and BCN logo. Click the *Medical/pharm drug benefit prior auth (commercial)* tile in the Applications tab.

Note: If you need to request access to our provider portal, see the <u>Register for web tools</u> webpage on **bcbsm.com**.

The Medical and Pharmacy Drug PA Portal will prompt you to select a site of care when you submit prior authorization requests for this drug. If the request meets the clinical criteria for the drug and is for one of the following sites of care, it will be approved automatically:

- Doctor's or other health care provider's office
- Ambulatory infusion center
- The member's home, from a home infusion therapy provider

Additional information or documentation may be required for requests to administer Gammagard Liquid ERC in an outpatient hospital setting.

Some Blue Cross commercial groups aren't subject to these requirements

For Blue Cross commercial groups, this prior authorization requirement applies only to groups that participate in the standard commercial Medical Drug Prior Authorization Program for drugs administered under the medical benefit. To determine whether a group participates in the prior authorization program, see the <u>Specialty Pharmacy Prior Authorization Master</u> <u>Opt-in/out Group list</u>.

Note: Blue Cross and Blue Shield Federal Employee Program[®] members and UAW Retiree Medical Benefits Trust (non-Medicare) members don't participate in the standard prior authorization program.
