Use the Medical and Pharmacy Drug PA Portal to submit prior authorization requests for pharmacy benefit drugs

Earlier this year, health care providers started submitting prior authorization requests for most medical benefit drugs to Blue Cross Blue Shield of Michigan and Blue Care Network through the Medical and Pharmacy Drug PA Portal.

We recommend that you also submit requests for most pharmacy benefit drugs through the Medical and Pharmacy Drug PA Portal because:

- You can enter requests for most medical and pharmacy benefit drugs in a single tool.
- You can submit prior authorization requests 24/7.
- In most cases, it prompts providers to answer questions that are specific to the drug being requested.
- It uses clinical criteria to guide you in submitting the proper information.
- It provides faster response times on your requests.
- It provides approvals within minutes (some requests require more time).
- It reduces administrative time.
