As reported in a <u>Sept. 17 provider alert</u>, health care providers must now do the following for in-lab sleep studies and for the implantation of hypoglossal nerve stimulation devices for most Blue Cross Blue Shield of Michigan and Blue Care Network commercial members:

- Submit prior authorization requests for most adult commercial members through the e-referral system.
- Submit plan notification for pediatric BCN commercial members through the e-referral system when the service will be performed in the East or Southeast region.
