Reminder: Changes to the inpatient appeal process for Medicare Plus Blue and BCN Advantage, starting Dec. 22

As <u>previously communicated</u>, Blue Cross Blue Shield of Michigan and Blue Care Network are transitioning the inpatient admission appeal process to our Grievance and Appeals department, starting Dec. 22, 2025. This applies to appeals related to acute inpatient medical-surgical and behavioral health admissions for Medicare Plus Blue and BCN Advantage members.

For adverse determinations issued on or after Dec. 22, 2025, providers will be able to submit appeals on behalf of members for all acute inpatient admissions. This means the provider and the member will have the same five-level appeal rights for all denied inpatient admissions.
